RE: THE GREENFIELDS FOUNDATION

We refer to your letter of 23 September 1999 where the Australian Electoral Commission states that it is of the opinion that the Foundation is an associated entity because it operates wholly or mainly for the benefit of the Liberal Party.

The reasons given for this opinion are, in short, that the Foundation was established for the purpose of receiving the assignment of the debts of \$4,750,000 owed by the Liberal Party to Ron Walker and that the Trustees have treated the Party, "in an uncommonly favourable manner in relation to the debts" by:

- only demanding two payments of \$100,000 each; and
- b) not charging or demanding interest

The Trustees have previously stated their view that they are not operating wholly or mainly for the benefit of the Liberal Party in correspondence to the Australian Electoral Commission on 15 January 1998 and again on 31 December 1998. The Trustees maintain this view. The basis for this view is that the Trustees are required by law to operate for charitable purposes and have not made any payments for any other purposes (except to meet administrative expenses and taxes).

In order to ensure that you have all the information which an associated entity would be required to disclose, we enclose, under protest and with a denial that The Foundation is an associated entity, unsigned but otherwise completed annual returns for the years 1996/97 to 1998/99.

The Trustees entirely deny that The Foundation has been constrained in meeting the objects of its deed. The Foundation has distributed to charity all moneys paid to it, save as required for expenses and tax, and are able to plan for a programme of continued giving.
