

# Candidate Return

For 2022 Federal Election held on 21 May 2022

Subsections 304(2) and 309(2) of the *Commonwealth Electoral Act 1918* (Electoral Act) require candidates or candidate agents to furnish a return within 15 weeks after the polling day in the election.

The due date for lodging this return is Monday 5 September 2022.

## Completing the Return:

- This return is for all candidates in the 2022 Federal election.
- This return is to be completed by the person notified to the AEC as the candidate's agent or by the candidate themselves, if no agent was appointed.
- A candidate who receives no gifts or incurs no electoral expenditure in relation to the election is required under section 307 or 313 of the Electoral Act to lodge a nil return.
- This return is to be completed with reference to the Financial Disclosure Guide for Candidates and Senate Groups.
- · Amounts should be reported on a GST inclusive basis.
- Under subsection 320(1) of the Electoral Act this return will be available for public inspection at <a href="https://www.aec.gov.au">www.aec.gov.au</a> from Monday 7 November 2022.
- Any supporting documentation included with this return may be treated as part of a public disclosure and displayed on the AEC website.
- The information on this return is collected under sections 304, 307, 309 and 313 of the Electoral Act.

## Part 1c: Details of donations received

#### \* Name and address details

- If the donation was from an unincorporated association (other than a registered industrial organisation), the name of the association along with the name and address of each member of the executive committee are required.
- If the donation was from a trust or foundation, the name or description of the trust or foundation along with the names and addresses of the trustees are required.

<sup>\*\*</sup> In this form **donation** is a **qift** within the meaning in section 287(1) of the Electoral Act.

## Part 2 - Electoral Expenditure (subsection 309(2) of the Electoral Act)

For the purpose of reporting electoral expenditure, under subsection 309(6) of the Electoral Act, a candidate in an election is taken to begin to be a candidate starting from the earlier of the following:

- the day that is 6 months before the day the person announced their candidacy; or
- the day that is 6 months before the day the person nominated as a candidate;

and is taken to cease being a candidate at the end of 30 days after polling day (20 June 2022).

Electoral expenditure is defined in section 287AB of the Electoral Act to be expenditure incurred for the dominant purpose of creating or communicating electoral matter. Further information on electoral expenditure can be found on the <u>AEC website</u>.

A **member of a Senate Group should not** complete this section of the Candidate Return. Any electoral expenditure must be included in a consolidated Senate Group Return.

Discretionary benefits include grants, contracts, payments and other benefits requiring the exercise of discretion by the Commonwealth or State or Territory, and do not include statutory entitlements.
